INSTRUCTIONS FOR AUTHORS (REVISED SEPTEMBER 2022)

Any article submitted to JIAS should be prepared according to the style guide and submitted as a Microsoft Word file, with all components of the manuscript, excluding any other author identifying information. A separate file of a title page compiled with academic curriculum vitae must be submitted with the manuscript to jias@snu.ac.kr or uploaded to the Journal's submission site at https://iia.jams.or.kr. Papers can no long be accepted via postal mail.

Please follow the formatting instructions carefully. It is the responsibility of the author(s) to ensure that papers are correctly submitted.

1. ARTICLE SCOPE AND TYPES

JIAS seeks to publish the best and most thoughtful scholarly reflections on international studies encompassing international commerce, international relations, and studies of any specific region.

Additionally, JIAS features articles that contribute to the improvement of general knowledge or empirical theory, meaning ONLY academic research papers that apply theoretical ideas and findings and extend to the methodology and statistical significance of results are accepted. Review essays or book reviews will not be accepted.

2. ORIGINALITY

JIAS does not evaluate works already published, previously accepted, or is being considered for publication elsewhere (including books and other forms of publication). According to our guidelines, a manuscript is not original enough if as much as half of the ideas or evidence has been published elsewhere. The manuscript submitted to JIAS should not be submitted elsewhere until the author receives a finalized decision of rejection from JIAS.

3. FORMATTING

JIAS will ONLY review a manuscript containing 8,000 to 10,000 words, including notes, tables and figures and references (Authors are asked to check a word count of their manuscript prior to submission, which most word processors will compute). All manuscripts should be double-spaced, in a 12-point readable font (this includes the title, appendices, tables and figures), and have a one-inch margin all around. Pagination is essential.

Abstract and Keywords:

All article submissions should include an abstract of up to 150 words and up to 6 keywords on the first page, numbered page 1. An abstract should summarize the whole paper, and be understandable without reference to the rest of the paper. It should contain no citations to other published work.

Tables and Figures

Useful tables and figures should not duplicate the text. They should supplement and clarify the text, otherwise, minimize the use of tables and figures. All tables and figures should be inserted into the text as appropriate. Overlarge tables and figures are discouraged. All tables must be formatted using the specific 'table' creation function in MS Word. Any other visual representation such as charts, diagrams, graphs and photos should be indicated as a figure.

All tables and figures should be numbered in sequence throughout the article, and cited in bold in the text. The title of the tables and figures should be centered on top of the table and figures and next to the table number. Major words need to be capitalized. Examples:

Table 1. Inspection Panel Claims Summary

Footnotes

Use footnotes on their respective pages (not endnotes). Footnotes should not be used for citing references.

Headings

Three headings should be sufficient for most articles.

First-level or main headings, designating the major section of the article, should be centered on the page and typed in all capitals. Example:

INTRODUCTION

Second-level headings should be typed in bold with <u>the left margin</u>, with major words capitalized. Example:

Two Modes of Contradictions

Third-level or paragraph headings should be typed with <u>the left margin</u>, in italics with major words capitalized. Example:

Religious Behavior of Certain Regions

4. LANGUAGE

All manuscripts must be written in English. When authors use foreign words or phrases, they should be italicized, except when they are naturalized, e.g., *chaebol*, *Festschrift*, but, bona fide, status quo. Authors should check and double check the spelling when using foreign words and phrases. Any technical terms that are not in a general-use dictionary with the meaning you ascribe to should be clearly defined. Put quotation marks around the first appearance of the term.

5. CITATION AND REFERENCE STYLE

The reference list should contain the complete facts of publication or availability for each source cited, using the formats shown in the following examples. References should be quoted in the text as name and year within parentheses and listed at the end of the paper alphabetically. Where reference is made to more than one work by the same author published in the same year, identify each citation in the text as follows; (William, 2001a, 2001b). If a work has two authors, give both names every time it is cited. For three authors, give all names in the first citation and et al. (italicized) in subsequent citations. Where four or more authors are listed in the reference list, please cite in the text as (Williams et al., 2001). All references listed in the end of the manuscript should be all cited in the text, vice versa.

The list of references should not be distinguished according to the type of the source. Alphabetize references by the last name of a first author, or a name of a corporate author, or periodical, if there is no human author or editor. Include complete titles for articles and books(including subtitles). Online citations should include date of access. Use double spacing between citations.

Spell out the first author's last and first name. If there are second and third author, spell out their first name before their last name. Middle name should be abbreviated.

In case of foreign publications, books, articles and websites, translate the main title in English as close as to the original text and put the original title (spelled out in English alphabet) in parenthesis. The name of the author(s) and the publisher should follow their official name in English.

Be sure that all references appearing in exhibits follow this uniform citation style as follows. Should you have more inquiries about referencing, please refer to the *AUTHOR-DATE Chicago style* of reference.

<u>JOURNAL ARTICLE</u>: The name of the journal should be italicized. Issue number of the cited journal should be indicated in parenthesis after the volume number. Page numbers are essential: Massey, Douglas S. and Nancy A. Denton. 1987. "Trends in the Residential Segregation of Blacks, Hispanics, and Asians: 1970-1980." *American Sociological Review* 52(6):802-825

<u>BOOKS</u>: The title of book should be italicized. The city of publication and the publisher should be indicated: Ward, Geoffrey C., and Ken Burns. 2007. *The War: An Intimate History*, 1941–1945. New York: Knopf.

TRANSLATED BOOKS: Fenandez-Shaw, Carlos M. 1999. The Hispanic Presence in North America: from 1492 to Today. Translated by Alfonso Bertodano Stourton and others. New York: Facts on File, Inc.

CHAPTERS IN BOOKS: Kelly, John D. 2010. "Seeing Red: Mao Fetishism, Pax Americana, and the Moral Economy of War." In Anthropology and Global Counterinsurgency, edited by John D. Kelly, Beatrice Jauregui, Sean T. Mitchell, and Jeremy Walton, 67–83. Chicago: University of Chicago Press.
